This policy tells you how we collect and use information.

Personal Information

What information do we collect?

The Club collects information you provide through the membership application form as well as information obtained from activity records documents.

How do we store the information?

All application forms and activity records are retained by the Membership Officer.

What do we do with the information?

The information is used to maintain a list of the Club members and to record the level of member activity and meeting participation during the year.

Do we share the information?

- Your name, suburb, phone number and e-mail address is distributed to all members unless you have opted out of sharing such information by informing the Membership Officer as outlined in the membership application form.

How do we protect the information?

All membership application forms are retained by the Membership Officer. The forms can only be viewed by members of the Club committee. All committee members are fully aware about the importance of confidentiality and maintaining the privacy and security of the information.

How do we deal with complaints and requests ?

- You may request access to personal information about you that we hold and you may ask us to correct your personal information if you find that it is not accurate, up-to-date or correct.
- You may make a complaint about our handling of your personal information.

How do we deal with photographs of members?

Members accept that the Club will regard their having consented to the publication of photographs of the member in the Club and/or PSPL publications/websites unless the member personally informs the Club Secretary as outlined in the membership application form.

Website Analytics
